


REQUEST FOR REASONABLE ACCOMMODATION

A **reasonable accommodation** is a modification or change Berkshire Housing can make to its facilities, policies or procedures that will assist an otherwise eligible client with a disability an equal opportunity to participate in Berkshire Housing programs, facilities and services.

This form is intended for use by Berkshire Housing participants/applicants to request a reasonable adjustment in a rule, policy, or procedure because of their disability or a family member's disability.

This form may be filled out by the participant/applicant with a disability unless the individual is a minor or cannot as a direct result of his/her disability. In this case the participant's/applicant's designee may fill out the form. If you cannot complete this form and do not have a designee, please ask your Program Representative for assistance. This form may also be used by Berkshire Housing to document a verbal request for a reasonable accommodation.
