Effective January 13, 2025, EOHLC will close its Housing Choice Voucher Program/Section 8 mobile voucher waiting list until further notice. Applications with a postmark, email, fax, or drop-off date of January 13, 2025 or later will not be accepted either by EOHLC or its regional administering agencies.

What does this mean for you?

- If you have applied for a mobile HCV voucher prior to 1/13/2025, your status on the waitlist will remain unchanged.
- If you are an active voucher holder, this does not impact your current mobile voucher.
- If you wish to apply for a HCV voucher, you may be able to do so at a different housing authority. Hearthway, Inc. does not have access to the information as to if external housing authorities have an open waitlist and/or accepting applications. You will need to use the attached contact details to reach out to these agencies. They are entirely separate from Heathway, Inc.
- You can apply to our many properties. We have properties across Berkshire County and many unit types. Some units have rent assistance attached to them and all our units are defined as affordable housing with rent restrictions. Applications are online, please visit www.hearthway.org, or can be picked up at our main office.
- You can apply for a mobile MRVP voucher which is issued through the MA Rental Voucher Program. Applications are online, please visit www.hearthway.org, or can be picked up at our main office.
